# **HUNTING LICENCES / PERMITS**

All hunts in this country requires some form of permit or licence. Failure to comply herewith could lead to a criminal record.

NHSA's position is that all it's members MUST ascertain that they acquire the necessary permit or licence before any hunt.

A hunting permit / licence is a written permission to either hunt in a specific Province or to hunt on a specific game ranch (farm) (permits are also required to transport game meat from the hunting venue to your home [butcher]).

Hunters must be in possession of such a permit /licence at all times in all provinces while they hunt or when they transport game meat. A permit giving a hunter permission to hunt and transport game meat on exempted farms can be downloaded from the "Provincial Hunt Regulations" page NHSA Form: Permission to Hunt & Transport Venison

Each of the nine provinces has its own hunting regulations.

Therefore, it is important that hunters know what these regulations entail and ensure that they comply accordingly before they hunt. In Gauteng, North-West, Mpumalanga and Limpopo hunters may hunt on an exempted farm without a licence, but they must have a permit from the landowner that gives them permission to hunt. On open farms, hunters must always have both a hunting licence and a permit.

In the other five provinces, hunters must **always** have a hunting licence.

<u>What is an Exempted Farm</u>: Landowners can apply for exemption from the relevant Provincial authority if the farm complies with certain conditions, such as proper fencing, and then the animals on the farm (ranch) is legally their property.

<u>What is an Open Farm</u>: On open farms, hunting is usually allowed during the hunting season only and with the appropriate hunting licence as the game animals on open farms are perceived to belong to the State.

All Provinces are required to annually publish hunting proclamations in the Government Gazette to announce the dates, times and condition for hunting in a particular province (this does, however, not always happen and then the previous year's proclamation should be followed). Open or hunting season for hunting is usually from May to August, but it can differ from province to province, and according to species. One may only hunt on an open farm during the proclaimed provincial hunting season and with an appropriate hunting licence.

#### WHERE TO APPLY FOR HUNTING LICENCES

Licences for the hunting of gamebirds are compulsory in all Provinces and must annually be acquired before the hunt – also note that daily bag limits differ per province and per species

#### **GAUTENG**

Exempted farms: same as Limpopo Province.

Open farms: Hunting licences obtained from Patience Mthembo, (011) 355 1207

#### **NORTH-WEST**

Exempted farms: same as Limpopo Province.

<u>Open farms:</u> The landowner must apply for a quota of game to be hunted each year. The Department of Nature Conservation will supply a hunting licence booklet to the farm owner that can be used to issue hunting licences to hunters.

Licences must be carried at all times during the hunting trip.

#### **LIMPOPO**

<u>Exempted farms:</u> The hunter does not need a hunting licence, but needs to be in possession of the form, Permission to Hunt and Transport venison (download on page)

<u>Open farms</u>: Hunting licences are compulsory. Hunters must also obtain written permission from the landowner to remove game meat from the farm.

A special permit is required for the transportation of Warthog and Bushpig meat. These permits are available from the landowner or from the District Veterinarian.

#### **KWAZULU-NATAL**

Hunting licences are available at most firearm-dealers in the province or from Ezemvelo KwaZulu-Natal Nature Conservation - tel. (033) 845 1154 or from the Kwazulu-Natal Hunters Association, at tel. (031) 709 3904 or fax (031) 709 3914.

## **NORTHERN CAPE**

Hunting licences are compulsory for all hunting activities without any restrictions on numbers and species.

Licences are available at any post office in the Northern Cape and at post offices in towns en route to the Northern Cape, i.e.: Vryburg, Potchefstroom, Bloemfontein, Beaufort-Wes, Van Ryhnsdorp, Bellville, Malmesbury, Worcester, Laingsburg, Prince Albert en Middelburg (Eastern Cape).

Hunters can also buy licences from post offices in Johannesburg at Rivonia, Sandton, Isando, Edenvale, Kemptonpark and Halfway House.

In the Pretoria region hunting licences for the Northern Cape can be bought at post offices in Centurion, Lynnwood Ridge, Montana Park and Brooklyn Square.

#### **EASTERN CAPE**

Hunting licences are valid for exactly one year from the day of purchase.

All hunters must be in possession of general hunting licences to hunt in the Eastern Cape Province. This licence is also valid for bird hunting, and is available from most firearm dealers in the Province

Hunters must be in possession of a general hunting licence, which is available at firearm-dealers and other offices of Cape Nature Conservation.

Immediate family members of landowners do not need a licence to hunt ordinary game.
