JAGGELEENTHEDE / HUNTING OPPORTUNITIES

NSA lede wie ook wildplase besit en binnelandse jagters verwelkom, het die geleentheid om hulle jagplase kosteloos op die NSA webwerf te adverteer. Indien u sou belangstel gebruik asb die onderstaande uitleg en ons sal die jaggeleentheid wat u aanbied onder "Hunting Opportunities" op die webwerf plaas;

- ID-nommer;
- Provinsie;

- Naam van plaas
- e-posadres
- webwerf se adres
- Naam van kontakpersoon en selfoonnommer
- Dui asb aan of u slegs geweerjagters akkommodeer en of u ook boog- en handwapen- en ook kamera-jagters akkommodeer.
- 'n Kort beskrywing van die spesies wat u te jag aanbied – maksimum 50 woorde asb
- 'n Kort beskrywing van die akkommodasie wat u aanbied – maksimum van 50 woorde asb
- 'n Kort beskrywing van die dienste wat u in u tarief ingesluit aan jagters aanbied (bv. voertuig, gidse, vuurmaakhout, slag van wild) – maksimum 50 woorde asb
- 'n Kort beskrywing van u slagteriewe (bv. voldoende slagplek, koelkamer, plek vir vleisverwerking deur jagter, of u vleisverwerking vir jagter doen, ens) – maksimum 50 woorde asb

U kan 'n total van 200 woorde in geheel gebruik (dit gaan hier oor plek en andersyds oor kriptiese inligting wat vir jagters leidrade kan wees).

Moenie vergeet as u ook gesaaides het waar vlugskuts kan kom jag nie – indien deel van u bedryf in gesaaides is en u het gespesialiseerde plek vir vlugskuts, kan u gerus so 'n geleentheid op sy eie adverteer – daar is konstant vlugskuts wat jaggeleenthede soek (onthou jagbare watervoëlspesies is ook 'n gesogte vir vlugskuts).

Indien u pryse vir wild wil aandui is u welkom, maar plaas dit asb in hakkies na die spesie se naam wat u in u lys van jagbare spesies aandui – selfde met akkommodasie en dagtariewe asb – ons het nie plek vir lang pryslyste nie.

U plaas se jaggeleentheid en kontakbesonderhede sal op die NSA webwerf bly totdat u aandui ons moet dit wysig of verwyder. Ons sal u jaarliks voortydig versoek om u pryslys en u aanbod aan te pas indien dit vir u nodig sou wees.

Ons het slegs een voorwaarde: u is verplig om ons in te lig van NSA-lede wat u as onveilige jagters of as onetiese jagters beskou (oneties beteken 'n persoon wat die NSA se jagterskode oortree (kyk Codes of Conduct op linker inhoudsopgawe).

Dis daardie deel van jag wat jaarliks vir die jagbedryf in die algemeen groot onguns bewys en dis ons almal se verantwoordelikheid om daardie deel van die jag uit ons gesamentlike bedryf uitgeskop te kry.

Teen drankmisbruik kan slegs u op die plaas optree – as NSA-lede egter onder die invloed in u veld ingaan om te gaan jag is die voorafgaande verantwoordelikheid weer ter sprake, maar ons glo u sal dit nie op u plaas toelaat nie.

HUNTING OPPORTUNITIES

NSA members who also own game ranches (game farms) where they welcome domestic hunters, have the opportunity to free of charge, advertise their ranches (farms) on the NSA website. Should you be interested, please use the layout below and we shall place your ranch's contact details under "Hunting Opportunities" on the website:

- ID-number;
- Province;
- Nearest town or city;
- Name of ranch (farm);
- e-mail address;
- website address;
- Name of contact person and cellular number;
- Please indicate whether you accommodate only rifle hunters, or if you accommodate bow-handgun-, and/or camera hunters too;
- A short description of the species you offer for the hunt – maximum 50 words please;
- A short description of the accommodation you offer – maximum of 50 words please;
- A short description of the services you include in your rates (i.e. vehicle, guides, fire wood, brunch, slaughter of game, game drive, etc.) – a maximum of 50 words please;

- A short description of your slaughtering facilities (i.e. adequate place to slaughter, cold room, a place where hunters can work their meat, or if you can do that for them for a fee, etc.) – maximum 50 words please.

You may use a total of 200 words (its all about space and short sets of information which should give hunters leads).

Please do not forget to mention wingshooting opportunities if part of your farm is also under horticulture – if you have opportunities for wingshooting your are thus welcome to advertise that too. If your wingshooting opportunity is specialised it might be better to advertise that separately – there are always wingshooters who are looking for new and better places to hunt (that includes waterfowling).

If you would want to include prices for the species you offer and for your accommodation, please indicate these in brackets after the species or at the accommodation description – we unfortunately do not have space for long price lists.

Your add will remain on the NSA website until you change the content or you ask us to delete it from the website. We shall annually give ample warning for adjustments to prices and or any changes you would want to make.

We have one precondition though: you are obliged to report NSA members who you perceive to be unsafe hunters or who are unethical hunters (unethical equals not adhering to the NSA Code of Conduct (see Codes of Conduct on left side menu).

It is that part of the hunt which annually does a lot of damage to the face of the hunting industry as a whole. It is our common responsibility to get that out of our system right to its roots (only you can act against the misuse of alcohol on your farm.

Should NSA members, however, enter your veld under the influence the aforementioned, our responsibility agreement is immediately in place, but we believe that is not something you allow on your ranch in any case.
